investment company Interkapital vrijednosni papiri d.o.o. made the following acquisitions of Company (treasury) shares in the name and on behalf of the Company at the regulated market of Zagreb Stock Exchange (ZSE).

- On August 29, 2025, 404 shares, identification code ERNT-R-A, were acquired at average price of EUR 181.7995 per share, representing 0.03% of the Company's share capital.

- On September 01, 2025, 130 shares, identification code ERNT-R-A, were acquired at average price of EUR 182.1077 per share, representing 0.0098% of the Company's share capital.

Following these acquisitions Ericsson Nikola Tesla d.d. holds in total 7.863 own shares, representing 0.59% of the Company's share capital.

The Company acquires its treasury shares with the purpose to award shares to employees under the Award Programs.
