investment company Interkapital vrijednosni papiri d.o.o. made the following acquisitions of Company (treasury) shares in the name and on behalf of the Company at the regulated market of Zagreb Stock Exchange (ZSE).

- On September 17, 2025, 2 shares, identification code ERNT-R-A, were acquired at average price of EUR 185.00 per share, representing 0.00015% of the Company's share capital.

- On September 18, 2025, 137 shares, identification code ERNT-R-A, were acquired at average price of EUR 187.9562 per share, representing 0.01% of the Company's share capital.

Following these acquisitions Ericsson Nikola Tesla d.d. holds in 8,232 own shares, representing 0.62% of the Company's share capital.

The Company acquires its treasury shares with the purpose to award shares to employees under the Award Programs.
