investment company Interkapital vrijednosni papiri d.o.o. made the following acquisitions of Company (treasury) shares in the name and on behalf of the Company at the regulated market of Zagreb Stock Exchange (ZSE).

- On October 09, 2025, 136 shares, identification code ERNT-R-A, were acquired at average price of EUR 197.3162 per share, representing 0.01% of the Company's share capital.

- On October 10, 2025, 125 shares, identification code ERNT-R-A, were acquired at average price of EUR 193.6360 per share, representing 0.009% of the Company's share capital.

Following these acquisitions Ericsson Nikola Tesla d.d. holds 10,540 own shares, representing 0.79% of the Company's share capital.

The Company acquires its treasury shares with the purpose to award shares to employees under the Award Programs.
