investment company FIMA-VRIJEDNOSNICE d.o.o. made the following acquisition of Company (treasury) shares in the name and on behalf of the Company at the regulated market of Zagreb Stock Exchange (ZSE).

- On November 05, 2025, 232 shares, identification code ERNT-R-A, were acquired at average price of EUR 192.78 per share, representing 0.017% of the Company's share capital.

- On November 06, 2025, 43 shares, identification code ERNT-R-A, were acquired at average price of EUR 192.00 per share, representing 0.003% of the Company's share capital.

Following these acquisitions Ericsson Nikola Tesla d.d. holds 11,579 own shares, representing 0.87% of the Company's share capital.

The Company acquires its treasury shares with the purpose to award shares to employees under the Award Programs.
