- On 05 June 2020, 311 shares, identification code ERNT-R-A, were acquired at a weighted average price of HRK 1,250.00 per share, representing 0.023354% of the Company's share capital.

Following this acquisition Ericsson Nikola Tesla d.d. holds in total 1211 treasury shares, representing 0.09094% of the Company's share capital.

The Company acquires its treasury shares with the purpose to award shares to employees under the Award Program and Loyalty Program.
